Retracement Survey A-Z

Friday, January 7, 2011 8:00 a.m. – 12:00 p.m.

Boundary surveying is more than just turning angles and gathering record information. It is a process performed in the context of client, adjoiners, and business demands. Often the surveyor in training or new practitioner is unprepared for the often complex interaction of competing interests while applying their technical skills. This workshop will go through the sequence of tasks ordinarily encountered during the course of a boundary survey. The purpose, interaction, and difficulties of the various tasks will be explored. Particular attention will be given to the documentation accompanying a boundary survey and the interaction with various parties often encountered during a boundary survey.

Undocumented Boundaries

Friday, January 7, 2011 1:30 – 5:30 p.m.

Practitioners often encounter situations where the client's possession boundary does not coincide with the record boundaries. Depending upon the circumstances, the possession boundary may become the ownership boundary. In other cases, acts of the party(ies) and surrounding circumstances may locate the boundary that the record alone fails to fix with clarity. The workshop will explain and discuss estoppel, acquiescence, practical location, agreement, adverse possession, and dedication. In addition to a basic understanding of these doctrines, the practitioner will learn what their role and responsibilities are in these cases.

THE NATIONAL FLOOD INSURANCE PROGRAM (NFIP) ELEVATION CERTIFICATE WORKSHOP

This four hour workshop reviews in detail all aspects of the NFIP's Elevation Certificate from the professional, compliance and insurance points of view. The workshop begins with a brief background on the history of the NFIP and introducing the terms and documents used by the program. This is followed by an indepth review of the seven sections of the Elevation Certificate and highlights the changes made in 2009, and includes discussion and examples of the 10 building diagrams provided in the instructions. Various building examples are then presented for participant discussions on the compliance issues associated with both sides of the NFIP. After which four examples for completing the Elevation Certificate will be discussed. Finally, links will be provided for obtaining more information about the NFIP.

L. Scott Samuels, P.E., Certified Floodplain Manager. Mr. Samuels currently manages Central Missouri Engineering Services, LLC (CMES) in Ashland, MO, which specializes in offering National Flood Insurance Program (NFIP) consulting services to local governments, lending institutions, private citizens, and engineering firms. CMES is very active with the preparation and submittal of Letter of Map Changes, the completion of the NFIP Elevation Certificates, and the presentation of five NFIP workshops in FEMA Region VII each year. Prior to starting CMES Mr. Samuels worked for six years as the Floodplain Management Engineer for the Missouri State Emergency Management Agency. Mr. Samuels has also worked for the City of Portland, ME and for private engineering/surveying firms in both Maine and Ohio. Mr. Samuels earned a Bachelor of Science degree in Civil Engineering from Colorado State University, Ft. Collins, CO in 1988 and is a registered professional engineer in the States of Missouri, Maine, Ohio, and West Virginia. Mr. Samuels is active in the Missouri Floodplain and Stormwater Managers Association having served as an area director and chair of the legislative committee, and he is currently acting as the Membership Secretary for the association.

<u>Steve Samuelson, CFM, NFIP Specialist.</u> Mr. Samuelson will be on hand during this session to answer questions from an NFIP perspective. Mr. Samuelson worked for Lyon County, KS, in planning, mitigation, enforcement and floodplain management. Mr. Samuelson has been with the Kansas Department of Agriculture, Division of Water Resources since 2007 and is a member of the Floodplain Management Team.

YOU MIGHT BE A RED-NECK SURVEYOR IF...

This course is a takeoff from Jeff Foxworthy, and will discuss mistakes that surveyors make that could earn them the title of "Redneck Surveyor". For example, You might be a redneck surveyor if....You don't know the prime directive. Come and find out if you are a redneck surveyor!

Norm L. Bowers, P.E., LS. Mr. Bowers was President of KSLS in 1980 and has served on the KSLS Board for two three-year terms. He was chairman of the 1979 committee that developed the first Minimum Standards for Boundary Surveys, has been a Registered Land Surveyor since 1973 and a Professional Engineer since 1978. Mr. Bowers retired as Johnson County Engineer in 2006, and now works part time as the Local Road Engineer for the Kansas Association of Counties.

PRACTICAL AND EFFECTIVE USE OF GPS IN SURVEY PROJECTS

This class will follow a GPS survey project through a typical sequence of steps from inception through completion. Discussion will include: coordination between the office and the field, equipment and people choices, establishing control, field notes, urban vs. rural issues, potential problems, checks as you go, information transfer from the field to the office, merging data from different sources, and showing method and datum within the deliverable. The class material is based on the presenters' experience and current resources and equipment.

<u>Wil Anderson, LS.</u> Mr. Anderson is the Survey Manager at BHC RHODES, based in Kansas City, Kansas. Mr. Anderson has a Bachelor of Applied Science – Surveying from Queensland University of Technology, QUT in Australia. He has been working with GPS since the early 1980's starting with the QLD Department of Mapping and Surveying and has since been involved with "various aspects" of GPS up to and including his current position with BHC RHODES. Those "various aspects" include: Lecturing with QUT, GPS Manager with a private survey firm in QLD, Technical Support with Sokkia, and Hardware Software Development with POINT, Inc. a joint venture between Novatel and Sokkia.

Mark Gabert, LS. Mr. Gabert is the Survey Operations Manager at BHC RHODES and is responsible for the day-to-day management of Surveying Services. R. Gabert is a licensed surveyor in Kansas and Missouri with twenty-two years of experience. His project experience covers a wide variety of land survey applications including public, private, and commercial development and hydrographic surveys. Mr. Gabert's professional experience also includes construction staking, boundary and engineering surveys, geodetic and vertical datum control establishment and riparian surveys.

KANSAS MINIMUM STANDARDS REVIEW

This course will review the May 24, 2010, Kansas Minimum Standards for Boundary Surveys and Mortgagee Title Inspections Standards of Practice. The class will compare the changes between the 1998 and 2010 standards, and provide attendees with the opportunity to ask questions and discuss the new 2010 standards and practices. This course will provide two PDH's towards the education requirement of KSA 66-14-1.

Kenneth P. Johnson, L.S. Mr. Johnson is President of Campbell & Johnson, Engineers, PA. Mr. Johnson is a second-generation owner of a Surveying, Engineering and Architectural firm in north-central Kansas. He graduated from Ottawa University in 1977, joining the firm in 1978 as a human resource person and becoming a licensed Land Surveyor and co-owner of the firm in 1986. Mr. Johnson has been a regular participant in the Salina Seminar Series since 1982 when the meetings were still held on the campus of Kansas Technical Institute. He is currently a member of the Salina (North Central) Chapter of KSLS, serving on the Salina Seminar Series committee, and is the originator of the "Surveying Contest". Mr. Johnson is also the chairman of K.S.L.S's Historical Committee, and is an active director in the State Board of KSLS.

Jason P. Johnson, L.S.. Vice-President of Landmark Surveying & Mapping, Inc. Mr. Johnson graduated with a degree in Surveying Technology and a Bachelors degree in Land Information Technologies from Kansas State University in December 2000. While at KSU, he served as President of the Student Chapter of KSLS. Mr. Johnson has been with Landmark since the spring of 2001 as the primary CAD operator, a surveying party chief, and has been a partner since 2008. He is currently a member of the Salina Chapter of KSLS and the NSPS. Mr. Johnson has served on the Salina Seminar Series committee and has helped Mr. Ken Johnson with the Surveying Competitions since their inception.

SECTION CORNER REPORT ONLINE ACCESS (SCROA)

The course will be a summary and discussion of the "Section Corner Report Online Access" or SCROA. We will discuss the progress of the project, the anticipated benefits, potential problems, and the hope for its completion and implementation. Background will be presented on how the project started, who is involved in its development and implementation, what involvement the Kansas State Historical Society will have, and the need for funding.

This session will cover how to research information needed to pass the LS exam – where to find certain information and good study habits to adopt. WRITING LEGAL DESCRIPTIONS

This session will cover the structure and order of the elements in writing a legal description and how to avoid the common mistakes of language, construction, and terminology.

Martin Martin, P.L.S. Ms. Martin is a senior project manager and survey manager for Wilson & Company, Inc., Engineers & Architects in Salina, Kansas. Ms. Martin graduated from Kansas State Salina with an Associate Degree in Land Surveying and a Bachelor's Degree in Land Information Technology. Ms. Martin was a part time instructor for surveying classes at Kansas State Salina. She is currently serving on the KSLS Board of Directors and is active on the State and Salina Chapter level. Ms. Martin is also a member of the Surveyor's Historical Society.

THE DEVELOPMENT OF THE PLSS AND LAND SURVEYING IN KANSAS. FROM THE KANSAS-NEBRASKA ACT TO THE 2011 KANSAS LEGISLATURE

The class will explore the development of the Public Land Survey System in Kansas under the 1855 Manual of Instruction with emphasis on the conduct and procedures of the original General Land Office Deputy Surveyors. The development and evolution of the County Surveyors and the law will be addressed, along with the current state of surveying for the Professional Surveyor.

Presented by:

<u>Steve S. Brosemer, LS, GeoTech, Inc.</u> Mr. Brosemer has been involved with the Salina Seminar Series since its inception. Currently, he serves on the Kansas State Board of Technical Professions as a Land Surveyor Representative, and is the Chair of the PE/LS committee. Mr. Brosemer is a graduate of Wichita State University with degrees in American History and Secondary Education, which is the foundation for his desire to teach history. He is the student of his mentor, the late James H. (Tony) Brosemer.

SURVEY MATH

Survey Math will cover those math skills that many of us take for granted in surveying. The focus of this class will be covering angle & slope calculations, coordinate geometry, and horizontal curve calculations three ways – 1) occupying a PC or a PT (and moving along the curve), 2) by occupying a PI, and 3) by occupying the Radius Point. With more and more software taking over calculations, the surveyors mathematical aptitude decreases and thus does not allow him to properly assess and check his work. Just having an understanding of the math that your calculator/software is doing is an advantage in checking your work

<u>Rod Zinn, LS.</u> Mr. Zinn has been affiliated with land surveying since 1985, including nine years of surveying in the Kansas City Metro area. He served as an instructor for more than ten years in the Civil Engineering Technology program at Washburn Tech, formerly known as Kaw Area Technical School, where he developed the curriculum for the surveying, mathematics and AutoCAD programs. In 2005 he entered the private sector as a survey coordinator for an engineering firm. In 2006 Mr. Zinn went to work for Landplan Engineering, P.A., in Lawrence, Kansas, where he is now the Survey Coordinator. Mr. Zinn holds an Associate of Design Technology degree from Johnson County Community College and a degree in Vocational Technical Education from Pittsburg State University.

SURVEY LAW--ERRORS IN LEGAL DESCRIPTIONS OR Ops! What to do when the description doesn't close.

John Black will present a seminar on how to find description errors and the potential consequences of those errors. He will also be distributing a downloadable program for checking a survey for closure on the spot by entering the calls into a hand-held calculator. He will include a formula for calculating the area of an irregular polygon given its vertices. You are welcome to bring your TI-83, 83Plus, 84, 89 and TI-Nspire calculators for a direct download after class.

John Black, Attorney at Law. Mr. Black has been an attorney since 1976 and taught surveying law at Kansas State – Salina for many years. He has taught math and science classes for the last 17 years. Mr. Black retired at the end of the last school year, but is starting to work on mediation, arbitration and application of a branch of mathematics, called "game theory", to law.
